- Policy 109 Recap
 - Callie put together Policy 109 (link in Agenda) Explains how grants and funding come into KPATA, including timeframes and drafted policy with option A and B

- The committee like option B. The only difference between A and B is the last two sentences
- o Jenny moved to approve option B as presented, Deanna seconded.
 - Discussion:
 - This policy gives more flexibility to ED with the grant process. It removes the need to email for approval. This applies to writing and negotiating, but the award still has to be approved
 - Last line is confusing: KPATA will write grants to support programs or will decide who will write the grants?
 - KPATA will NOT share grant writing tools and write grants for individual programs
 - Clarify what is meant by support
 - Worked to revise option B and changed wording of last two sentences
 - Funding will be prioritized to meet the needs of local Parents as Teachers programs. KPATA will also provide information on grant funding and other revenue generating opportunities to members.
- Monica made a friendly amendment to adapt last two sentences of option B, Laurie seconded. Motion passed unanimously.
