

### **Details of Training:**

Child Abuse and Neglect: Recognition, Reporting & Supporting Kansas law states that most professionals who work with children, including medical professionals, social workers, nurses, educators and others, are mandated reporters and are required by law to report suspicion of child abuse or neglect. This presentation will address areas of risk and protective factors, definitions of child abuse and neglect per Kansas law and provide examples of signs and symptoms. Participants will also learn the appropriate responses to suspected abuse or neglect, discuss what to do in the event of child disclosure and understand Kansas mandated reporter laws. This training is approved by KDHE for 1.0 child care licensing hours.



## **Breastfeeding Message of the Month**

### THE BASICS OF Kansas Breastfeeding Coalition, Inc.

MANY BREASTFEEDING FAMILIES WORRY ABOUT THEIR ABILITY TO MAKE ENOUGH MILK FOR THEIR INFANT. THE MAJORITY OF MOTHERS WILL MAKE THE PERFECT AMOUNT TO NOURISH THEIR LITTLE ONE. BREASTMILK PRODUCTION IS BASED ON SUPPLY AND DEMAND. THE MORE MILK REMOVED FROM THE BREAST, THE MORE MILK WILL BE MADE. EMPTY BREASTS MAKE MORE MILK. SO BREASTFEEDING OR PUMPING A MINIMUM OF 8 TIMES A DAY WILL MAINTAIN ALL THE MILK THE BABY NEEDS. THERE WILL ALWAYS BE MILK AVAILABLE FOR BABY EVEN IF BABY JUST ATE OR MOM JUST PUMPED. PLUS, BREASTS WILL MAKE MILK INSTANTLY WHEN BABY BEGINS TO NURSE OR MOM PUMPS.

AS A CARE PROVIDER, YOU CAN SUPPORT BREASTFEEDING FAMILIES BY APPLAUDING THEIR COMMITMENT AND EFFORTS TO PROVIDE BREASTMILK TO THEIR BABY, HANDLE THEIR BREASTMILK WITH CARE, USE APPROPRIATE AMOUNTS TO AVOID WASTE, OFFER TO KEEP SOME EXTRA MILK IN THE FREEZER FOR TIMES BABY MAY WANT A LITTLE MORE. DO NOT OFFER FORMULA AS THIS WILL DECREASE HER SUPPLY AND SHAKE HER CONFIDENCE. IF BABY IS HAVING A GROWTH SPURT AND WANTING EXTRA MILK FOR A FEW DAYS, A BETTER SUGGESTION IS HAVING MOM PUMP AN EXTRA TIME OR TWO OR USE SOME OF THE FREEZER MILK. AND FINALLY,

IF MOM IS WORRIED ABOUT HER MILK SUPPLY YOU CAN CONNECT HER WITH RESOURCES IN HER COMMUNITY TO HELP! THE KANSAS BREASTFEEDING COALITIONS HAS AN UP-TO-DATE RESOURCE GUIDE FOUND HERE AND YOU CAN ORDER BREASTFEEDING 911 CARDS HERE FOR A SMALL SHIPPING FEE TO GIVE TO YOUR WORRIED FAMILIES.
