

#### **SUCCESS STORY**

Mom has worked very hard to secure the safest, most loving environment for [child] and has done so by leaning into her support systems. Mom worked through an organization to give guardianship to her grandmother so [child] could attend preschool this year while she worked and her grandmother worked tirelessly to set up support for [child's] special needs through the school district and county. The family has already worked with the school to create an IEP for [child] for his kindergarten year starting in the fall. Mom struggles with her mental health and was recently accepted into rehab to support her in getting and keeping a steady job. The family puts [child's] needs first and has worked to become a secure unit for both Mom and [child]. This family followed through with visits and implementing strategies and resources throughout their two years in the program and they will continue to use their bond with each other and the skills they've learned to give [child] his best chances.

#### Membership, Nominating & Governance





#### Purpose:

- Membership Grow and diversify KPATA membership; provide annual Membership Feedback Opportunities reporting results to the Board.
- Nominating Fill open positions on the KPATA Board of Directors being mindful of representation from all regions of the state.
- Governance Monitor KPATA's fidelity to the bylaws; review and present Policies and Procedures updates or changes.

#### Advocacy



#### Purpose:

The Advocacy Committee welcomes back the legislators to each session and is responsible for educating them on the function and need for investment in Parents as Teachers programs across the state. The Committee does this by organizing an Advocacy Day at the Capital and via email and phone communications with legislators. There are times when efforts are needed with more direct advocacy with certain bills that may come up for vote that could impact PAT programs. Additionally, engaging the community in advocacy efforts is a goal.

### **Education and Training Committee**



#### Purpose:

The purpose of the training and education committee is to research and determine the training needs of KPATA members and parent educators providing PAT home visit services in Kansas. Following the determination of those training needs, high-quality training will be set for the program year, by the committee members, in order to support the professional growth of KPATA members and to meet the required training expectations as determined by PATNC.

# **Kansas Head Start**

#### TEN THINGS TO KNOW ABOUT KANSAS HEAD START PROGRAMS

- 1.SINCE 1965, HEAD START HAS OFFERED OPPORTUNITY AND HOPE TO YOUNG CHILDREN AND FAMILIES IN OUR KANSAS COMMUNITIES AND ACROSS THE NATION. NEARLY 6,300 INFANTS, TODDLERS, AND PRESCHOOLERS ARE ENROLLED IN KANSAS HEAD START PROGRAMS
- 2. HEAD START IS A PROVEN MODEL FOR HIGH-QUALITY EARLY EDUCATION AND AN EFFECTIVE TWO-GENERATIONAL APPROACH.
- 3. KANSAS HEAD START PROGRAMS COLLECTIVELY EMPLOY 2,500 DEDICATED HEAD START STAFF MEMBERS.
- 4. OVER \$90+ MILLION IN FEDERAL HEAD START FUNDS FLOW INTO LOCAL COMMUNITIES EACH YEAR FOR HEAD START PROGRAMMING.
- 5. HEAD START PARTNERS WITH PARENTS TO STRENGTHEN FAMILIES, ACTIVELY ENGAGING THEM AS THEIR CHILDREN'S FIRST AND MOST IMPORTANT TEACHERS.
- 6. HEAD START SUPPORTS PARENTS IN PROVIDING FOR THEIR FAMILIES BY OFFERING A SAFE, RELIABLE PLACE FOR THEIR CHILDREN TO GROW AND START ON THE PATHWAY TO SUCCESS.
- 7. HEAD START EASES THE IMPACTS OF ECONOMIC AND SOCIAL CHALLENGES ON YOUNG CHILDREN AND THEIR FAMILIES.
- 8. KANSAS HEAD START PROGRAMS ARE VALUABLE COMMUNITY PARTNERS, SUPPORTING LOCAL BUSINESSES THROUGH THE PURCHASES OF GOODS AND SERVICES AND COLLABORATING WITH PUBLIC AND PRIVATE ORGANIZATIONS.
- 9. LOCALLY DESIGNED HEAD START PROGRAMS EFFICIENTLY ADDRESS THE UNIQUE AND COMPREHENSIVE NEEDS OF THE CHILDREN, FAMILIES, AND COMMUNITIES THEY SERVE.
- 10. EVERY DOLLAR INVESTED IN HEAD START RESULTS IN A LONG-TERM RETURN OF \$7-\$9.

# **Kansas Head Start**

Dear Head Start Partners, Friends, and Champions,

The Kansas Head Start Association serves as the voice for the Kansas Head Start community - 6,200 children, 2,500 staff, and 23 Head Start organizations in communities across the Kansas. The mission of KHSA is to strengthen leadership, learning, partnership, and advocacy opportunities for Head Start families, staff, and programs.

Head Start is a federally funded grant program. In Kansas, annual federal funding for Head Start is just over \$90 million. Earlier this spring, media reports raised concerns about the future of Head Start funding in the federal budget for next year (FY26). While there is no current proposal to eliminate Head Start funding, until Congress passes, and the President signs, a final FY26 funding bill, we remain committed to elevating the critical importance of Head Start for children and families in Kansas and across the nation.

Continued federal funding in FY26 and beyond is essential for maintaining access to the early education, health services, and economic supports offered by Kansas Head Start programs. KHSA is asking the Head Start community and Head Start champions to share this message with others. What can you do?

- Talk to your friends, family, and neighbors about Head Start and why it is important for the children and families in our communities. Connect them with the <u>Kansas Head Start</u> <u>Association Facebook page</u> and/or the <u>National Head Start Association Facebook</u> page.

# 60 Years of HEAD START IN KANSAS

What can you share with others about Head Start?

- Without stable and reliable funding for Head Start, nearly 6,000 families in our state would be immediately impacted.
- When parents of young children have access to Head Start, they do not face
  the difficult decision of choosing between their livelihoods and a safe, reliable
  place for their children to grow and start on the pathway to success.
- Head Start is a model for high quality early education. It is an effective twogenerational approach.
- For every \$1 spend on Head Start, there is a \$7-\$9 return in long-term savings.
  Why? Head Start reduces costs associated with later, additional support
  services at school, like speech and hearing therapy, and with reliance on
  government assistance. In fact, parents who went to Head Start as children are
  less likely to qualify for Head Start and other government assistance programs
  when they have children of their own, strengthening families for future
  generations.

Head Start programs provide intensive, comprehensive early education in the majority of Kansas counties through Head Start preschool services and Early Head Start services for pregnant women, infants, and toddlers.

- Over \$90 million in federal Head Start funding flowed into Kansas's economy in FY2024 – directly to the local programs who provide these services in their communities.
- Almost 6,300 children participate in Kansas Head start programs.
- Nearly 2,500 individuals work in Head Start program in Kansas and are an integral part of the state's early childhood workforce.
- Over 4,900 parents were able to work, go to school, or participate in job training as a result of Head Start support.

# SCPK ADVISORY COUNCIL MEETING FOCUSES ON STRATEGIC INITIATIVES

On May 1st, the Supporting Care Providers of Kansas (SCPK) Advisory Council met with team members from Praxis Nonprofit Strategies. The meeting centered on outlining the organization's work plan and identifying key areas where the Advisory Council's expertise can significantly support SCPK's initiatives.

An essential outcome of the discussion was the establishment of several vital committees. These committees are designed to be instrumental in shaping SCPK's upcoming programming and strategies. The unique perspectives and specialized knowledge of Advisory Council members will be invaluable in driving the success of these efforts, directly contributing to SCPK's growth and impact across Kansas.

Here is an overview of the committees and their respective focus areas:

- Strategic Planning: This committee will be instrumental in drafting SCPK's strategic plan and fundraising strategy. It will also be responsible for monitoring key benchmarks and providing guidance to the Program Director during the implementation phase.
- Program Quality: Dedicated to enhancing SCPK's services, this committee will provide essential feedback on service delivery methods. It will also support the design, implementation, and summarization of annual survey results to ensure continuous improvement.

- Communications: This committee's focus is on increasing SCPK's visibility throughout Kansas communities. Its work will include advising on the development of the organization's website and social media presence.
- Finance: This committee will play a crucial role in the financial oversight of SCPK, assisting in the preparation and approval of the annual budget. Members will also participate in quarterly meetings to review and monitor budget implementation.
- Development: Focused on securing resources for SCPK, this committee will assist the Program Director in networking with potential funders. It will also offer expertise in the fundraising process and review draft grants prior to submission.

The formation of these committees highlights SCPK's commitment to using the diverse talents within its Advisory Council to advance its mission and better serve Family, Friend, and Neighbor care providers throughout Kansas.


